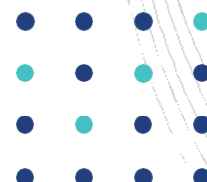

The name of the presenting author should be underlined. Body of the text should be justified with 11 font size of Times New Roman with single spacing. Posters must be of the size: 1-meter wide and 1-meter height with word limit 250.
